4. JILL LANE, PARKING RESTRICTIONS FOR VEHICLES OVER 6FT WIDE

Mr. Kinnard presented a brief to the Commission which stated the following options for parking restrictions on Jill Lane:

- 1. Do nothing, leave as-is, low traffic volume cul-de-sac.
- 2. Paint Red Curb on west side of street the length of cul-de-sac opening, approximately 120ft excluding the driveway opening which is equivalent to around 7 spaces, which would be lost. About the same for east side.
- Create 6ft width restriction on both sides of cul-de-sac opening, reducing the available traveled way (30ft-12ft=18ft) to 18ft. Only creating a width restriction on one side, would most likely reduce the available traveled way by 2ft down to 16ft.

Staff recommended Option 3 as it would allow adequate emergency access and not eliminate any parking spots. Director Leja stated some residents have voiced concerns over losing parking spots. Considerable Commission comments, questions and discussion followed regarding the options for parking restrictions on Jill Lane.

Vice Chair Krulikowski moved to choose Option 2, paint red curb on west side of Jill Lane, the length of cul-de-sac opening, approximately 120ft excluding the driveway opening. Commissioner Paden seconded the motion which carried 3-2.



La Mesa Municipal Code:

12.08.120 - Traffic commission-Powers and duties.

The traffic commission shall exercise the powers and duties as provided in this title and in the traffic ordinances of the city. In addition, the commission may approve other traffic issues as directed

by the city council of the city of La Mesa and as set forth within the organization, rules, and procedures of the traffic commission.

Whenever the traffic commission is required or authorized to place or maintain official traffic control devices, said commission may cause such devices to be placed or maintained.

It shall be the further duty of the traffic commission to serve as an advisory board to the city council on matters relating to traffic issues that require city council approval as provided in the traffic ordinances of the city.

12.08.060 - Traffic-Mobility Commission commission-created.

There is hereby created a transfer-mobility commission to consist of five nine voting members. All five nine voting members shall be residents of the city. Of the nine voting members, five shall be members of the general public. One member shall have substantial experience as a vulnerable road user, who frequently walk, ride a bicycle, or use another vulnerable non-car mode of transportation. One member shall have significant experience with climate or environmental issues. The city public works director shall be a non-voting, advisory member of the commission. In addition, the city public works director, or his/her designee, shall serve as a non-voting, advisory member of the commission. The chief of police, or his/her designee, shall serve as a non-voting, advisory member of the commission. The La Mesa Spring Valley and Grossmont High School Districts may each designate a non-voting advisory member.

12.08.070 - Commission—Appointment.

Voting mMembers of the traffic commission Mobility Commission shall be appointed by the Mayor with the approval of the city council, with the exception of the Mobility Commission member that is designated by the Environmental Sustainability Commission.

12.08.080 - Commission—Terms of office.

The term of office for each appointed member appointed by the Council shall be four years, which shall commence on July 1 and terminate on June 30, four years thereafter. Member's terms shall be maintained so that not more than two-three terms expire in any given year and appointments may be made for less than a four-year term in order to accomplish that purpose.

12.08.090 - Filling vacancies.

Each vacancy on the <u>traffic commissionMobility Commission</u> shall be filled for the unexpired portion of the term vacated in the manner set forth in Section 12.08.070.

12.08.100 - Expiration of terms.

In the event the reappointment in the manner set forth in Section 12.08.070 is not made upon the expiration of a term of office, a member shall continue in office until reappointment or until his/her successor is appointed and qualified.

12.08.110 - Statement of economic interests.

Each member as given in Section 12.08.060 shall comply with the provisions of the conflict of interest code of the city of La Mesa.

12.08.120 - Traffic commission—Powers and duties.

The traffic commission Mobility Commission shall exercise the powers and duties as provided in this title and in the traffic mobility ordinances of the city. In addition, the commission may approve other traffic provide advice on other mobility issues as directed by the city council of the city of La Mesa and as set forth within the organization, rules, and procedures of the traffic commission Mobility Commission.

Whenever the traffic commission is required or authorized to place or maintain official traffic control devices, said commission may cause such devices to be placed or maintained.

It shall be the further duty of the traffic commission to serve as an advisory board to the city council on matters relating to traffic issues that require city council approval as provided in the traffic ordinances of the city. advise the City of La Mesa on mobility issues including but not limited to, the implementation of neighborhood traffic calming activities, Vision Zero, and other plans for mobility improvements. The Mobility Commission shall also advise the City of La Mesa about the mobility elements of climate action planning, concurrently and in coordination with the Environmental Sustainability Commission.

Before the adoption of the City of La Mesa's annual or biannual budget, the Mobility Commission shall formally advise the Council on La Mesa's priorities for our transportation budget, CIP project list, and plans for grant applications for transportation improvements.

12.08.130 - Compensation.

All appointed members shall be paid such allowance as compensation for expenses incurred in their attendance at authorized meetings within the city of La Mesa as the council may from time to time fix by resolution.

12.08.140 - Study by members—Attendance at conferences.

The members of the traffic-commission. Shall inform themselves on matters affecting the functions and duties of the commission. For that purpose, such members may attend meetings, conferences, or hearings on subjects or issues relating to traffic-mobility as authorized by the city council.

12.08.150 - Travel expenses.

The reasonable travel expenses incidental to such attendance shall be charged upon the funds allocated by the city council for such purposes.

12.08.160 - Organization—Rules and procedures.

The traffic commission shall establish rules, regulations, and procedures consistent with the requirements of the law to govern their activity.

12.08.170 - Absence and removal of members.

Members of the traffic-commission. Who absent themselves from three consecutive regular meetings for any reason shall be recommended for removal from membership on the commission to the city council by the chairperson; however, said absentee commissioner has the right to appeal to the city council. The city council has the authority to appoint or remove any member of a commission at any time, for any or no reason, by a majority vote of the city council.

12.08.180 - Decorum at meetings.

Members of the commission and persons in attendance at meetings of the commission shall conduct themselves in an orderly manner and in compliance with the commission's rules or, in the absence of such rules, with the rulings of the presiding officer respecting applause, noise making, and conduct. Any person found by the foregoing or to be disrupting the orderly progress of the meeting, shall be ordered by the presiding officer to remove himself or herself, and to remain barred, from the meeting at which such violation occurs.
