6. RESOLUTION GRANTING THE CITY MANAGER AUTHORITY TO NEGOTIATE A COST SHARE AGREEMENT WITH THE CITY OF CHULA VISTA TO COMPLETE A COMMUNITY CHOICE AGGREGATION FEASIBILITY STUDY ON BEHALF OF BOTH CITIES

Councilmember Parent stated his concerns with partnering with the City of San Diego in a JPA for a Community Choice Aggregation program and requested that the feasibility study look at multiple JPA governance models with different cities.

A discussion ensued between Council and staff regarding the potential governance and operational models of the Community Choice Aggregation program and having the feasibility study look at a variety of JPA governance models.

ACTION: Motioned by Vice Mayor Parent and seconded by Mayor Arapostathis to adopt the resolution granting the City Manager authority to negotiate a cost share agreement with the City of Chula Vista to complete a Community Choice Aggregation Feasibility study on behalf of both cities.

11. CONSIDERATION OF AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LA MESA AMENDING TITLE 24 OF THE LA MESA MUNICIPAL CODE TO ESTABLISH PROVISIONS FOR EMERGENCY SHELTERS AS REQUIRED BY STATE LAW

Notice of the hearing was given in accordance with legal requirements, and the hearing was held on the date and at the time specified in the notice.

Mayor Arapostathis opened the hearing for Item No. 11 at 6:12 p.m.

City Attorney Sabine read the title of the Ordinance.

Senior Planner Kinnard provided a PowerPoint presentation regarding the requirement to update the City's emergency shelter regulations to comply with State Law and the City's Housing Element, the provisions of the City's Housing Element related to emergency shelters, the proposed operational standards for emergency shelters, and the City's existing regulations for emergency temporary shelter events.

A discussion ensued between Council and staff regarding defining homelessness and emergency, the proposed operational standards for emergency shelters, the factors to be used when determining parking requirements, and the standards and regulations churches would need to comply with to open an emergency shelter.

Following Council questions, Mayor Arapostathis asked if anyone from the audience wished to speak.

ACTION: Motioned by Councilmember Alessio and seconded by Councilmember Baber to close the hearing since there was no one in the audience who wished to speak.
